You may be eligible for a discount on the basis of your claim-free insurance record before moving to British Columbia.

### TO QUALIFY

You must verify your claim-free record by obtaining "Claim History" letters from your previous insurance company(s). For each year of claim-free insurance immediately preceding the date you first obtained an Autoplan policy or British Columbia driver's licence, you may qualify for a 5% discount up to a maximum of 40% representing eight or more continuous claim-free years.

### TIME LIMIT

Claim History letters must be received within six months of the date you purchased the plate/policy listed on this application in order to receive a full refund.

### In order to be accepted, your claim history letter(s) must:

- List the principal operator named on your ICBC policy
- Be issued by the insurance company (not by a broker or agent)
- Be issued on insurance company letterhead
- Include complete contact information for the insurance company e.g. (phone, fax, mailing address)
- Indicate the issue date of the letter
- Include policy number(s)
- Provide exact dates of coverage e.g. (January 1, 2002 to January 1, 2010)
- Provide details of any claims for all persons listed on the letter (insurance company ratings are not acceptable) or state there were no liable or at fault claims
- Be written in English or fully translated by a certified translator & submitted with original claim history letter.
- Confirm record for up to eight (or more) years immediately preceding the start of your first Autoplan policy or British Columbia driver's licence.

### Company owned vehicles

Claim history letters for vehicles insured in a company name must be accompanied by the following documentation:

- If the applicant was an employee of the company: a letter from the employer indicating the dates the vehicle was assigned to the applicant and confirmation the vehicle was used for business and pleasure purposes.
- If the applicant was/is an owner of the company: a letter from a company representative or the applicant stating that he or she was an owner of the company and had use of the vehicle for business and personal use.

**Note:** the claim history letter must specifically name the applicant as a driver on the company policy.

## INSTRUCTIONS

### Request claim history letter

- Contact your previous insurance company(s) to request your claim history letter(s).
- Claim history letter(s) should be sent to you. Please do NOT ask your insurance company to send them directly to ICBC.
- Claim history letter(s) are required for each Registered Owner or for the Principal Operator (if different from the Registered Owner(s)).

### Once claim history letter is received

- Complete and sign the Application for Claim-Rated Scale Discount.
- Enclose your application fee (made payable to ICBC, \$20 for each B.C. plate/policy for which the discount is requested).
- The application fee is **non-refundable**.
